Election Notice

A secret ballot election for the office of section chairman at SJU is being conducted by mail. Ballots for this election are being mailed to members on January 05, 2012. Any eligible member who has not received a ballot in the mail at home by January 17, 2012 or any member who spoils a ballot may request a new ballot by contacting Ron Gliganic at 631-987-7006 between 0700 and 1700. You will need to provide your name, address, station, employee number and job code. If you request and return a placement ballot, only the replacement ballot will be counted.

Instructions for Mail Voting

- To vote, mark the ballot in the box that represents your choice. Do not place your name, initials or any other identifying information on the ballot. **Ballots that contain identifying marks will be voided.**
- Write-in votes will not be accepted.
- Place your ballot in the small white envelope that has the words SECRET BALLOT on the front and seal the envelope. Place the sealed SECRET BALLOT envelope inside the pre-stamped envelope addressed to TWU Local 562 SJU Election 2011.
- Your name and address have been affixed to the return envelope pre-addressed to the Election Committee. Your name on this envelope will identify you as an eligible voter. **DO NOT DAMAGE YOUR MAILING INFORMATION ON THE BALLOT ENVELOPE**, This information will be used by the election committee to determine eligibility. Your vote will remain secret because the SECRET BALLOT envelope containing your ballot will be separated from the return ballot envelope and mixed with other SECRET BALLOT envelopes before it is opened and the ballots counted. **Envelopes received with damaged or missing information will be voided.**
- Mail the return envelope as soon as possible. No postage is necessary if mailed in the United States. **IN ORDER TO BE COUNTED, THE ELECTION COMMITTEE MUST RECEIVE YOUR MAILED BALLOT BY NO LATER THAN 9:00 A.M. TUESDAY February 03, 2011.**
